MIDDLESEX COUNTY BOARD OF SOCIAL SERVICES SEPTEMBER 11, 2025 BOARD MEETING MINUTES

Sandra Coleman opened the meeting by reading a statement of compliance with the Open Public Meetings Act of 1975.

Ms. Coleman asked for a moment of silence in remembrance of the September 11, 2001 terrorist attacks.

A motion was made by Mr. Marozine, and seconded by Ms. Blackwell, approving the payment of bills as listed. The motion was unanimously adopted.

OLD BUSINESS

Staff reports on new applications in August 2025 showed 256 TANF applications; 466 GA applications, and 1,131 applications for SNAP. SNAP recertifications totaled 1,747 in August. In August, our receptionists assisted 2,876 individuals, with 354 of them visiting the Perth Amboy office. During the month, our call center answered 10,176 calls.

A copy of the Medicaid Redetermination Report for the month of August 2025 was submitted to the Board for review. The report shows a total caseload of 41,508 individuals. Approximately 25 percent of our redeterminations are overdue.
